APPOINTMENT LETTER

- 5. You will be on probation for a period of Three months from the date of joining which may be extended for such terms as may be considered appropriate by the Management. Upon satisfactory completion of your probation, your services will be confirmed by written order with the Company.
- 6. During the probation period and any extension thereof, your services may be terminated by either side by giving one-week (7 days) notice or salary in lieu thereof. However, on confirmation, this contract can be terminated by either side by giving one-month notice or salary in lieu thereof.

reasonably, brings or is likely to bring you or the Company into disrepute or is materially

adverse to the interests of the Company.

13. If any information furnished or declaration given by you in regard to your employment to the

Company is found to be false or any material information wilfully suppressed, your

appointment would be liable for termination without any notice or compensation.

14. During less work or no work, management may terminate your job with 7 days' notice

without any salary or compensation thereof. You would get the salary for the period you have

worked in the office excluding the notice period.

15. Your engagement with the Company is governed by and shall be construed and interpreted in

accordance with the laws of India and your engagement shall be subject to the jurisdiction of

the Courts of Bhubaneswar, India.
