

7. 14. During less work or no work, management may terminate your job with 7 days' notice without any salary or compensation thereof. You would get the salary for the period you have worked in the office excluding the notice period.
15. Your engagement with the Company is governed by and shall be construed and interpreted in accordance with the laws of India and your engagement shall be subject to the jurisdiction of the Courts of Bhubaneswar, India.
