

APPOINTMENT LETTER



7. 13. If any information furnished or declaration given by you in regard to your employment to the Company is found to be false or any material information wilfully suppressed, your appointment would be liable for termination without any notice or compensation.
14. During less work or no work, management may terminate your job with 7 days' notice without any salary or compensation thereof. You would get the salary for the period you have worked in the office excluding the notice period.
15. Your engagement with the Company is governed by and shall be construed and interpreted in accordance with the laws of India and your engagement shall be subject to the jurisdiction of the Courts of Bhubaneswar, India.

You are requested to sign this letter signifying your acceptance of the same for our records.


