
7. During the probation period and any extension thereof, your services may be terminated by either side by giving one-week (7 days) notice or salary in lieu thereof. However, on confirmation, this contract can be terminated by either side by giving one-month notice or salary in lieu thereof.

Upon termination of employment, you will return all the properties of the Company which may be in your possession to your Departmental Head. It would be obligatory on your part to get a proper relieving letter from the Management before your services are deemed to be concluded.

8. Your appointment in the company is full time and you shall, while in the services of the Company, devote your full time and attention exclusively for the Company's Work and Responsibilities assigned to you. 14. If any information furnished or declaration given by you in regard to your employment to the Company is found to be false or any material information wilfully suppressed, your appointment would be liable for termination without any notice or compensation.
15. Your engagement with the Company is governed by and shall be construed and interpreted in accordance with the laws of India and your engagement shall be subject to the jurisdiction of the Courts of Bhubaneswar, India.
